San Jose Golf Scholarship Application Instructions

Statement of Intent

The San Jose Golf Scholarship Program will ensure that qualifying San José residents will have access to participation to City of San Jose Golf Courses. *All requests are subject to available funding.*

Eligibility Criteria

- 1. The San Jose Golf Scholarship Program will operate in two (2) steps. Step 1 is for the customer to submit the application and eligible documents in person at the participating Golf Courses. Step 2 is for the customer to register for the class if scholarship is approved.
- 2. San Jose Golf Scholarship Applications will be available at San Jose Municipal Golf Course, Los Lagos Golf Course and Rancho Del Pueblo Golf Course. Applications may also be downloaded online. Applications for the San Jose Golf Scholarship Program and proof of eligibility will be accepted in person only at each available location for review. If qualified, scholarships will be available only during the program application year indicated on the San Jose Golf Scholarship Application. Funding is subject to availability.
- Scholarship recipient must be a San José resident. Proof of residency includes utility bills dated within 60 days of the application that have the name and address of the participant, parent or legal guardian and must be submitted with application.
- (1) Proof of Identity: (3a) Participant/Parent/Legal Guardian must be currently enrolled and Identification Card show proper documentation for one of the following programs: Driver's License Passport Temporary Assistance for Needy Families (TANF) Subsidized Housing HUD Section 8 rent subsidy (2) Proof of Residency: Food Stamps (California Advantage or Cal-Fresh) • Medi-Cal California's Life Line Program (reduced rates for phone) Utility Bill dated within 60 Women, Infants, & Children (WIC) days of application Supplemental Security Income (SSI) **Current Automobile Registration** Foster Youth Eligibility document with If both parents/guardians or participants are unemployed and receiving participant/parent/guardian and CA State Unemployment Insurance benefits address listed Parent/guardian or participant enlisted as an "active" member in the U.S. Military Veterans and/or dependents of veterans (DD214 Card)
- 4. Eligibility documentation is required and copies must be submitted with application.

- 5. San Jose Golf Scholarships will be awarded on a first-come, first-served basis. Customer will be notified of award status within the submission date range. Scholarships are subject to available funding.
- 6. If scholarship application is approved, it will be awarded upon completion of registration. Customer is responsible for completing the class registration. San Jose Golf Scholarship awards do not guarantee enrollment and do not replace the registration process. San Jose Golf Scholarship funds are not available for expenses beyond the listed price such as, but not limited to: supplies, materials, food and/or transportation.
